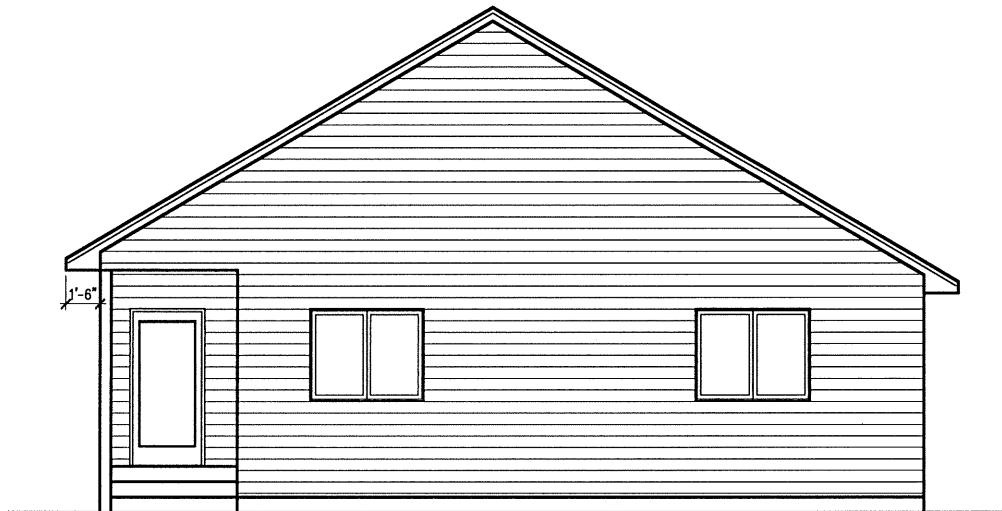


FRONT ELEVATION

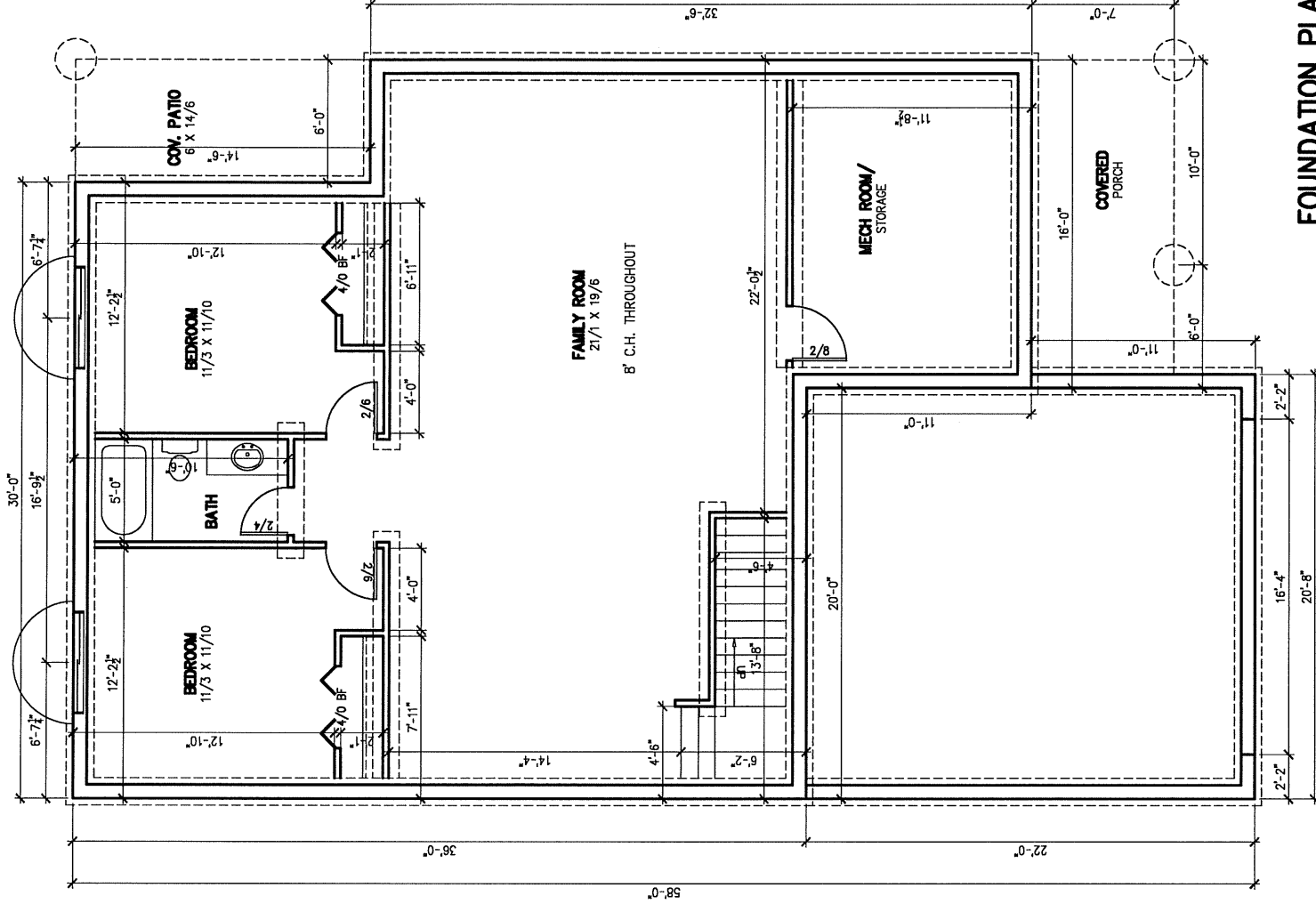
FLOOR PLAN
